## **MINUTES**

The Board of Councilmen of the Town of Rural Hall held their regular meeting on May 13, 2019 at 7:00 PM in the Town Hall Council Chambers. The following members were present: Mayor Larry T. Williams - presiding; Mayor Pro Tem John N. McDermon; Councilman Timothy M. Flinchum; Councilman C. Thomas Griggs; Councilman Ricky S. Plunkett; Town Manager Megan M. Garner; Town Clerk Dora K. Moore; and Town Attorney D. Barrett Burge.

Pledge of allegiance to the flag was led by Clerk Moore.

## Public Comment Period:

David McKnight, 715 Irish Road, shared his desire for the Council to encourage businesses, specifically food establishments, to come to Rural Hall; opposition to the proposed dump in the 27045 zip code; raise taxes; hire another firefighter; provide educational classes for street maintenance employees; build a new fire station; and, increase pay and education for firefighters. Mayor Williams thanked Mr. McKnight for his comments. Councilman Plunkett noted the proposed dump mentioned would be a debris dump on Germanton Road.

Rachel Katzer, 225 Cook Street, has placed her secluded, 18-acre property on the market. Due to the property size and location, she is receiving inquiries about horses. She asked if Ordinance #294 prohibited horses, and if it does, would the Council grant her an exception. Attorney Burge stated Ordinance #294 does prohibit horses. The Council is not a zoning board so variances can not be granted by the Council. Council agreed to investigate Mrs. Katzer's request and give her an answer.

<u>Approval of Minutes:</u> Councilman C. Thomas Griggs made a motion to approve the April 8, 2019 regular meeting and May 6, 2019 briefing minutes. Mayor Pro Tem John N. McDermon seconded the motion and motion passed unanimously.

Councilman Timothy M. Flinchum made a motion to approve and seal the April 8, 2019 closed session minutes. Councilman Ricky S. Plunkett seconded the motion and motion passed unanimously.

**Financial Reports:** Manager Garner reported that with the transition to a new financial system in February there are still some conversion issues. The accounting clerk is working with the Town auditor and financial system provider, Edmunds, to resolve these issues so the bank reconciliations can be completed, and financial reports presented to the Council.
