## **MINUTES**

The Board of Councilmen of the Town of Rural Hall held their regular meeting on April 8, 2019 at 7:00 PM in the Town Hall Council Chambers. The following members were present: Mayor Larry T. Williams - presiding; Mayor Pro Tem John N. McDermon; Councilman Timothy M. Flinchum; Councilman C. Thomas Griggs; Councilman Ricky S. Plunkett; Town Manager Megan M. Garner; Town Clerk Dora K. Moore; and Town Attorney D. Barrett Burge.

Pledge of allegiance to the flag was led by Clerk Moore.

Public Comment Period: No comments were received.

<u>Approval of Minutes:</u> Councilman C. Thomas Griggs made a motion to approve the March 11, 2019 regular meeting and April 1, 2019 briefing minutes. Mayor Pro Tem John N. McDermon seconded the motion and motion passed unanimously.

Mayor Pro Tem John N. McDermon made a motion to approve and seal the February 11, 2019 closed session minutes. Councilman Timothy M. Flinchum seconded the motion and motion passed unanimously.

**Financial Reports:** Manager Garner reported the Town's September 2018 and October 2018 financial statements that were originally approved were incorrect due to a formula error associated with Powell Bill funds, which has since been corrected. Councilman Ricky S. Plunkett made a motion to approve the revised September 2018 and October 2018 financial reports as presented by Manager Garner. Councilman Timothy M. Flinchum seconded the motion and motion passed unanimously.

Manager Garner presented the November 2018, December 2018 and January 2019 Town financial reports to the Council. She noted the January 2019 receipts were significantly lower than January 2018 due to significantly lower ad valorem taxes. Councilman Ricky S. Plunkett made a motion, seconded by Mayor Pro Tem John N. McDermon, to approve the November 2018, December 2018 and January 2019 Town financial reports as presented. Motion passed unanimously.

## **NEW BUSINESS:**

<u>Audit Contract:</u> The Town's current audit contract with Gibson & Co. expired last fiscal year so Requests For Proposals were issued. Six responses were received ranging from \$8,000 to \$14,560. Eddie Carrick, CPA, in Lexington was the lowest. His firm has extensive local government experience and his niche seems to be small municipalities. Several of his references were checked and all had great things to say. Bermuda Run is one of their customers. Councilman Ricky S. Plunkett made a motion to approve an audit contract with Eddie Carrick, CPA and authorize Manager Garner to sign the contract. Councilman Timothy M. Flinchum seconded the motion and motion passed unanimously.

Resolution to Retain First Citizens Bank: Mayor Williams presented a resolution to the Council opposing the reduction of services at First Citizens Bank Rural Hall and requesting them to reconsider their decision. Mayor Williams noted a copy of his letter to First Citizens Bank's Chairman Frank Holding, Jr. has been placed in the Council's Dropbox. Councilman Ricky S. Plunkett made a motion approving Resolution #796. Mayor Pro Tem John N. McDermon second the motion and motion passed unanimously. (Resolution #796 has been placed in the Ordinance Book.)

Councilman Timothy M. Flinchum made a motion to enter into closed session to discuss attorneyclient privilege pursuant to NCGS 143-318.11(a)(3) at 7:33 PM. Councilman C. Thomas Griggs seconded the motion and motion passed unanimously.

Mayor Williams reconvened the regular meeting at 8:13 PM with no action to report.
